I. OLD BUSINESS - Items for Discussion and Possible Action:

Necessary Reconsideration and Revote on 4 Agenda Items from the 3/18/26 Meeting Agenda Due to Quorum Issues

Note: After the March 18, 2026 board meeting, it was discovered that the Board took action on two funding items (Item 22 – Valley Cultural Foundation Summer Concert Booth and Item 24 – Congress of Neighborhoods sponsorship) and two PLUM items (Wisteria at Warner Center, items 17 & 18) when we did **not** have the quorum required by our bylaws. The WH-WCNC bylaws set the Board quorum at **13 board members present and able to vote**.

On each of these March 18 items, one board member properly recused due to a conflict and six other members were absent, leaving only **12 eligible members present** when the items were taken up, as reflected on the BAC forms. Under our bylaws and the Ralph M. Brown Act's requirement that actions be taken by a lawfully constituted majority (Gov. Code §§ 54952.6, 54953), the Board should not have **considered, discussed, or voted on** these items without 13 eligible members present on the item. Because that quorum requirement was not met, the original actions on Items 22 and 24 to approve funding are procedurally defective.

After this issue was discovered, the Treasurer, in accordance with fiduciary obligations, promptly self-reported the funding errors to the Office of the City Clerk's NC Funding Program (which had also not caught the error), and the City Clerk placed stop-payments on the checks that had already been mailed for these items.

Re-agendizing these items and taking new votes after public comment and board discussion *De novo* [anew, starting over fresh] at a properly noticed meeting is the standard "cure and correct" approach contemplated by the Brown Act for actions taken without proper procedure (Gov. Code § 54960.1), and it is also required by the City Clerk in order to reissue payment on these funding requests. The purpose of these April 8 agenda items is to explain the issue on the record and to take new votes on **the same motions the Board improperly adopted on March 18**, with a confirmed quorum of at least 13 eligible board members present on each item, so that our funding and PLUM decisions rest on a solid legal footing.

Item No. 1 *De novo consideration of prior item 26-129*

(26-132) Approve \$2,500 from the 2025/2026 Outreach Budget for the annual WHWCNC Booth at Valley Cultural Foundation Summer Concerts (10 concerts + July 4th)

\$2,500 is the least cost for a booth for 10 concerts and the July 4th Fireworks Program which will also include a tent, two chairs, (3) NC parking passes, WHWCNC signage on VCF promotional outreach materials and one Sunday for the NC to appear on stage to address the stakeholders. The booth provides opportunities for board members to meet with stakeholders, hear their issues and promote the mission of the WHWCNC.

The motion is supported by Invoice #2029 dated March 9, 2026. Payment of \$2,500.00 is due by April 15, 2026, as required to ensure WHWCNC is included in the printed materials and signage for the concert season.

WHEREAS, the Applicant, Wisteria Warner Center CCRC, LLC, has requested a Main Conditional Use Permit – Master Alcohol Permit (Class 2) pursuant to Los Angeles Municipal Code Sections 12.24.W.1 and 13.B.2.2 to allow the sale and dispensing of alcohol within up to six previously approved ground-floor restaurant and retail tenancies located in the Independent Living Building (“Building 1”) of the Wisteria Warner Center Continuing Care and Retirement Community (CCRC); and,

WHEREAS, the Project site consists of approximately 17.63 acres (767,760 square feet) located at 5490, 5500, and 5600 North Canoga Boulevard at the southeast corner of Canoga Avenue and Burbank Boulevard (APN 2149-016-027; Tract PM 2005-1466 Lot A), within the Commerce-SN Zone and the Commerce District of the Warner Center 2035 Specific Plan area; and,

WHEREAS, the Wisteria Warner Center CCRC is a previously approved multi-phase mixed-use senior living development currently under construction pursuant to City Planning Case No. DIR-2018-7428-SPP, including the primary Independent Living Building and ancillary structures; and

WHEREAS, the instant request pertains to a maximum of six of the twelve previously approved retail and restaurant tenancies and seeks authorization for ancillary alcohol service within those commercial spaces; and,

WHEREAS, the request would authorize four tenancies to provide a full line of alcoholic beverages for on-site consumption with limited off-site carryout, one tenancy to provide beer and wine for on-site consumption, and one tenancy to allow full-line alcohol sales for off-site consumption with associated on-site tasting; and,

WHEREAS, proposed alcohol service hours are between 11:00 a.m. and 2:00 a.m., and the Project includes 24-hour on-site security staffing; and

WHEREAS, the Project is located within the Warner Center 2035 Specific Plan area, which establishes the regulatory framework for mixed-use development within the Warner Center community;

RE: PLUM Committee Recommendation: Amendment to Ordinance 177327 - VNY Land Use

Dear Councilmember Bob Blumenfield,

On behalf of the Woodland Hills–Warner Center Neighborhood Council (WHWCNC), and consistent with a recommendation of the WHWCNC Planning and Land Use Management (PLUM) Committee, we write to express support for a motion requesting a targeted amendment to Ordinance No. 177327 governing land use at Van Nuys Airport.

The current regulatory framework for the airport, established through the 2006 Van Nuys Airport Plan and codified by Ordinance 177327, created clear land-use designations intended to guide development within the airport footprint. These distinctions, particularly between Aviation and Airport Commercial uses, were adopted by the City Council to ensure appropriate aeronautical activity, compatibility with surrounding communities, and consistency with the City's adopted planning framework.

Recent proposals and solicitations issued by Los Angeles World Airports raise concerns that these land-use boundaries could be altered through parcel consolidation or reclassification prior to completion of the forthcoming Van Nuys Airport Specific Plan. Development concepts that combine parcels with different use designations, or convert land between Aviation and Airport Commercial categories, risk undermining the integrity of the existing ordinance before the comprehensive planning process directed by Council File 23-1339 is completed.

The proposed ordinance amendment provides a practical safeguard. It does not halt development at the airport; rather, it ensures that projects moving forward remain consistent with the land-use designations already adopted by the City until the Specific Plan process is completed and considered by the Council.

Because development at VNY Airport directly affects surrounding communities - including operational, environmental, and land-use compatibility impacts - WHWCNC respectfully urges you to take the lead in filing this action. The motion would direct the Department of City Planning, in consultation with the City Attorney, to prepare an amendment clarifying that any land-use or zoning changes within the Van Nuys Airport Plan area occur only through the Specific Plan process.

Ensuring that potential changes to land-use designations occur through that process rather than through individual project approvals will help maintain transparency, protect the community, and preserve the integrity of the airport's planning framework.

This position was approved by a vote of the Woodland Hills-Warner Center Neighborhood Council Board on April 8, 2026 at a Brown-Act qualified meeting.

Thank you for your consideration and for your continued attention to responsible planning at Van Nuys Airport.
