Every person wishing to address the Board must enter the meeting via the above Zoom link or dial (669) 900-6833, and enter 884 2295 9967 and then press # to join the meeting. When prompted by the presiding officer, to provide public input at the Arts and Culture Committee Meeting of the Woodland Hills – Warner

Center Neighborhood Council meeting, the public will be requested to dial *9 by phone or use the Raise Hand option on Zoom, to address the Board on any agenda item before the Board takes an action on an item. Comments from the public on agenda items will be heard only when the respective item is being considered.

Comments from the public on other matters not appearing on the agenda that are within the Committee's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the Committee is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Committee or Board meeting. Public comment is limited to 1 minutes per speaker, unless adjusted by the presiding officer of the Board.

SB 411 Updates:

In the event of a disruption that prevents the Arts and Culture Committee from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the Arts and Culture Committee control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the Arts and Culture Committee shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that prevents the Arts and Culture Committee from broadcasting the meeting may be challenged pursuant to Section 54960.1.

The Arts and Culture Committee shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the Arts and Culture Committee and offer comments in real time.

Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of theArts and CultureCommittee, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate.

- (i) If the Arts and Culture Committee provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph, to provide public comment until that timed public comment period has elapsed.
- (ii) If the Arts and Culture Committee does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public comment.
- (iii) If the Arts and Culture Committee provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed.

Proposal: Holiday Solar Lights Installation on Ventura Boulevard

Project Overview

The Arts and Culture Committee proposes installing solar-powered lights along Ventura Boulevard, from Winnetka Avenue to De Soto Avenue, for the 2024 holiday season. This project aims to enhance our community's cultural celebration through sustainable and festive lighting.

Location

Ventura Boulevard, from Winnetka Avenue to De Soto Avenue

Project Goals

- 1. Enhance the community's holiday experience through festive lighting
- 2. Promote sustainability with solar-powered installations
- 3. Create a unifying cultural element along Ventura Boulevard
- 4. Foster community engagement through a cultural installation ceremony
- 5. Strengthen inter-committee collaboration

Budget Request and Materials

The Arts and Culture Committee requests a budget of \$1,500 USD for materials.

Proposed mix of solar lights (total \$1,494.75):

- 10 strands Brightech string lights: \$699.90
- 3 Sunforce motion lights: \$359.97
- 5 packs LITOM spotlights: \$199.95
- 3 packs Aootek sensor lights: \$155.97
- 2 packs SOLPEX ground lights: \$65.98

Note: This budget covers only the cost of materials. Installation costs are not included.

Cross-Committee Involvement

This project presents an opportunity for collaboration across multiple committees:

- Arts and Culture Committee: Lead organizer, oversees cultural aspects
- Community Service Committee: Agreed to assist with installation
- Environmental and Beautification Committee: Collaboration on sustainable design and placement to enhance street aesthetics while promoting environmental benefits
- Public Safety Committee: Consultation on lighting placement for improved street safety

We welcome input and participation from all committees to make this a truly community-wide initiative.

Community Involvement

- We propose a "Lighting Ceremony" to mark the installation's commencement, celebrating our community's diverse holiday traditions.
- Local businesses along Ventura Boulevard will be invited to participate and potentially extend the lighting to their storefronts.

Timeline

- Planning and Procurement: October-November 2024
- Installation: Early December 2024
- Lighting Ceremony: Early December 2024 (date TBD)

- Lights Display: Throughout the holiday season

- Removal: Early January 2025

Cultural Significance

While the installation will be simple, it represents our community's unity in celebration. The proposed Lighting Ceremony offers an opportunity to showcase our cultural diversity, potentially featuring:

- Brief speeches from community leaders
- A symbolic "switching on" of the lights
- Small cultural performances or readings

Conclusion

This solar light installation will contribute to our community's holiday spirit while promoting sustainability and inter-committee collaboration. The project aligns with both cultural enrichment and environmental stewardship, thanks to the involvement of the Environmental and Beautification Committee. The addition of a cultural ceremony elevates this project beyond mere decoration, making it a true celebration of our community's arts, culture, and unity.
