*PUBLIC INPUT ON AGENDA ITEMS – The public may address the Board on any agenda item before the Board takes an action on an item. Comments from the public on agenda items will be heard only when the respective item is being considered. <u>Public comment is limited to (1) minute per speaker.</u>

*PUBLIC INPUT ON MATTERS NOT ON THE AGENDA - Comments from the public on other matters not appearing on the agenda will be heard during the General Public Comment period. Please note that under the Brown Act, the Board is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public, that is within the WHWCNC Board's jurisdiction, may become the subject of a future Board meeting.

General Public Comment is limited to(1)minute per speaker and 20 minutes total.

Due to zoom teleconference which allows greater public comments at meetings; Public Comment is limited to (1) minute per speaker, unless adjusted by the presiding officer of the meeting.
