In conformity with the September 16, 2021 Enactment of California Assembly Bill 361 (Rivas) and due to concerns over COVID-19, the Woodland Hills-Warner Center Neighborhood Council meeting will be conducted entirely telephonically with a call-in option or internet based service option.

When calling-in telephonically, the public is requested to dial \*9, when prompted by the presiding officer, to address the Board on any agenda item before the Board takes an action on an item. Zoom users should use the "raise hand" feature.

**AB 361 Updates**: Public comment cannot be required to be submitted in advance of the meeting, only real-time public comment is required. If there are any broadcasting interruptions that prevent the public from observing or hearing the meeting, the meeting must be recessed or adjourned. If members of the public are unable to provide public comment or be heard due to issues within the Neighborhood Council's control, the meeting must be recessed or adjourned.

Any messaging or virtual background is in the control of the individual board member in their personal capacity and does not reflect any formal position of the Neighborhood Council or the City of Los Angeles.

**\*PUBLIC INPUT ON AGENDA ITEMS** – The public may address the Board on any agenda item before the Board takes an action on an item. Comments from the public on agenda items will be heard only when the respective item is being considered. *Public comment is limited to 2) minute per speaker*.

#### 5. Update from NCSA

Mr. Archibald spoke of the February NCSA meeting and its focus on SB1383 and its relation to LA's Green Initiative. The March NCSA meeting addressed Democracy vouchers as a way to democratize election funding.

# 6. Arbor Day Update

Mr. Archibald shared that we have agreement from David Hussey, the Executive Director of ECR CHS and City of Los Angeles to advance the tree planting project in the tree wells on the perimeter of ECR CHS.

# 7. Green Street Initiative Update and Possible Vote on a CIS for the full Board Approval – <u>See attached</u>

Mr. Farassati wants to direct to a specific program (Safe, Clean Water Program) and to a specific area on Ventura Blvd. We agreed to include the original two locations and identify the Safe, Clean Water Program. In addition, we will modify the CIS to reflect the fact that there might be private funding for a median. This will be on the April Committee meeting agenda for a vote on whether to advance the CIS to the larger Board.

# 8. Woodland Hills Elementary Beautification Discussion and Possible Vote - See attached

Danielle Hastie presented a NPG request to help beautify the area around Woodland Hills Elementary. This would include wood boarders to restrict dirt, drip irrigation and drought tolerant plants.

Leslie Simon made a motion to approve the request of \$5,000 as an NPG for Woodland Hills Elementary, Brian Archibald seconded.

Mr. Farassati indicated that a bubbler irrigation system would be better than a drip irrigation system.
