### DRAFT CLOSURE PLANS FOR THE U.S. DEPARTMENT OF ENERGY HAZARDOUS WASTE MANAGEMENT FACILITY AND RADIOACTIVE MATERIALS HANDLING FACILITY SANTA SUSANA FIELD LABORATORY

**PUBLIC COMMENT PERIOD: AUGUST 13, 2018 TO OCTOBER 12, 2018**

On August 13, 2018, the Department of Toxic Substances Control (DTSC) released the Draft Closure Plans (Plans) for the U.S. Department of Energy (DOE) Hazardous Waste Management Facility (HWMF) and the Radioactive Materials Handling Facility (RMHF), in Area IV of the Santa Susana Field Laboratory (SSFL) for public review and comment. To ensure ample opportunity for the public to comment, and for ease of access to the Draft Plans and the supporting DOE Standard Operating Procedure for Demolition of Facilities in Area IV at the Santa Susana Field Laboratory, Revision C, August 2016 (SOP) on our website, DTSC is extending the public comment period from 45 days to 60 days, which is from September 27, 2018 to **October 12, 2018**.
