PLUM Chair Karen Koe made the following motion:

As pertaining to Case No. DIR-2016-0291, having held three public hearings for the application by California Home Builders for construction of a multi-unit residential and commercial complex at 6200 Variel Avenue, Woodland Hills, located in the College District of Warner Center as delineated by the Warner Center 2035 Plan, the Planning, Land Use and Mobility Committee hereby finds that:

WHEREAS, there have been several meetings with the developer regarding this project which have improved the project overall; and

WHEREAS, based on the application materials being presented by the applicant dated January 22, 2016, the requirements of the Warner Center 2035 Specific Plan have been substantially met for a request for PROJECT PERMIT COMPLIANCE FOR A MIXED-USE PROJECT to be constructed in one phase with approximately 270,430 sq. ft. of combined residential and commercial floor area in the WC College District Zone; and

WHEREAS, additional suggested improvements and changes listed in "Considerations" have been discussed and accepted by the developer;

THEREFORE, IT IS HEREBY RESOLVED, that the Planning, Land Use and Mobility Committee, for the findings and conditions stated herein, finds that the proposed application for a new 270,430 sq. ft. mixed-use complex in a 6 story structure over a 3-story parking garage (one story subterranean) with 241 residential units, seven live/work units, and retail/commercial space for a grocery store, restaurant, retail service stores, co-working office space, 4 hotel/sleeping units and a membership gym located at 6200 Variel Avenue receive the support of the Woodland Hills-Warner

Center Neighborhood Council for the requested actions with the following condition(s):

1.) A parkway shall be added to the curb along Variel Avenue. The width of the new curb shall be similar to the width of the existing tree wells (at a minimum) to better conform to the intent of Fig. 9, Table 1 of the 2035 WC Plan.

2.) Applicant's proposed artwork for the mural at the intersection of Variel Avenue and Erwin Street shall be presented to the PLUM Committee, the WHWCNC full board and the CD-3 Council office for review and comments.

PLUM Chair Karen Koe made the following motion:

As pertaining to Case No. DIR-2015-4099-SPP, having held two public hearings for the application for demolition of two 3-story single story apartment buildings at 22425 Del Valle St., 91364, and the subsequent construction of a single 3-story, 5-unit apartment building totaling 7,402square feet, the Planning, Land Use and Mobility Committee hereby finds that:

WHEREAS, the proposed structure meets the requirements of the Ventura Blvd./Cahuenga Blvd. Specific Plan, including required parking allotment and setbacks. There are no variances or exceptions requested; and

WHEREAS, the applicant has agreed to implement suggested improvements and modifications to the submitted plans;

THEREFORE, IT IS HEREBY RESOLVED, that the Planning, Land Use and Mobility Committee, for the findings and conditions set forth herein, recommends that the WHWCNC support the proposed application for the demolition of two 1-story, 3-unit apartment buildings and construction of one 3-story, 5-unit apartment building with semi-subterranean parking for 10 vehicles.

Item no. (3) Dennis DiBiase, Vice-Chair, WHWCNC (16-016) CPC-2015-4499-CA/ENV-2015-4500-CE

Dennis DiBiase, Vice Chair, WHWCNC made the following motion:

The Woodland Hills-Warner Center Neighborhood Council strongly opposes the "Proposed Citywide Zoning Code Amendment, CPC-2015-4499-CA/ENV-2015-4500-CE, Amendment to the Small Lot Ordinance" in its current form for the following reasons:

1. The ordinance contains an administrative review process with clearance required solely by the Director of Planning. This takes away the public review process. Given the history of small lot subdivision development in the City and the potential for detrimental effects on adjacent single family properties and neighborhoods, this is clearly not appropriate.

2. The design standards that are intended to be added to the ordinance are not included and are critical to fully evaluate the affect the changes will have on the community.

3.Bike parking and guest parking is not addressed.

4. The goal of requiring common driveways being completely open to the sky at all times is not addressed.

5. There is a stated goal that additional design standards will be included for the units that face the public street. (Sloped roofs or an open deck will be required at these locations.) Although the goal is stated the standards are not included.

6.A stated goal of requiring centralized trash enclosures is not included.

7. The ordinance needs to increase the side and rear yards of these developments when adjacent to existing single family residences regardless of the underlying zone of the project or adjacent single family property.
