Application for a Conditional Use Permit for the continued use of an existing Pre-school/Day Care with over-height fence, expansion of existing structure to 971 sq. ft., and increase in number of students from 40 to 64.

As pertain to Case No. DIR-2016-261-CU-F, having held two public hearings for the application for the continued use of a pre-school/day care center, the construction and enlargement to the east wall of the existing garage to 971 sq. ft., and an increase in occupancy from the currently permitted 40 students to 64 students, the Planning, Land Use and Mobility Committee

recommend the Woodland Hills-Warner Center Neighborhood Council SUPPORT the application with the following considerations and proposals:

WHEREAS, the proposed structure increase will still meet the requirements of the area Community Plan; and

WHEREAS, the existing fence is already over-height and will remain; and

WHEREAS, the applicant has agreed that the child count shall not exceed the 64-child limit; and

WHEREAS, the applicant has agreed to implement the following improvements and conditions at set forth below;

THEREFORE, IT IS HEREBY RESOLVED, that the Planning, Land Use and Mobility Committee, for the findings and conditions stated herein, finds that the proposed application for the issuance of a Conditional Use Permit and the relief from City Code Section 12.08 for an overheight front yard fence receive the support of the Board of the Woodland Hills-Warner Center Neighborhood Council for the requested actions with the following conditions:

- 1.) Plant and maintain Creeping Fig vines along the cyclone fence on the Fallbrook Ave. property line and add drip irrigation system.
- 2.) Add planting containers with greenery on blacktop area along Hatteras St. fence.
- 3.) Provide trash enclosure with sidewalls, and locate it away from all abutting residential

properties.
