Discussion and possible action:

As to Case Number(s) ZA-1984-667-PAB-PA5 and ENV-2016-2257, having received no (0) letters of complaint and three (3) letters of support from adjacent neighbors, the Planning, Land Use and Mobility ("PLUM") Committee recommends the Board of the Woodland Hills-Warner Center Neighborhood Council support the approval of the renewal request for the continued sale and dispensation of a full line of alcoholic beverages on the 986 sq. ft. rear patio with 40 seats, and the 800 sq. ft. front outdoor patio with 22 seats which are part of an existing 4,807 sq. ft. restaurant that has been deemed to be approved by the Conditions Compliance Unit. The restaurant is seeking no (0) modifications to conditions approved on 12/8/2014. The hours of operation for the restaurant and front patio are from 11 a.m. to 2:00 a.m. daily, and the rear patio hours are from 11:00 a.m. to 10:15 p.m. Sunday through Thursday, and 11:00 a.m. to 11:15 p.m. on Friday and Saturday.

<u>Item no. (5) Sean McCarthy, Chair- Beautification Committee</u> (16-082)

Discussion and possible vote:

Motion for the Board to approve the following recommendation:

CREATION OF MEDALLION SIGN NOTIFYING THE PUBLIC OF LOS ANGELES MUNICIPAL CODE SECTION 28.04 NOT TO POST SIGNS ON PUBLIC PROPERTY.

WHEREAS: The City of Los Angeles has an ordinance, Los Angeles Municipal Code Section 28.04, which states in part: Sec (a) "No person shall paint, mark or write on, or post or otherwise affix, any hand-bill or sign to or upon any . . . street lamp post, hydrant, tree, electric light or power or telephone or telegraph or trolley wire pole, . . . street sign or traffic sign". AND

WHEREAS: L.A.M.C. 28.04, Sec (c)(1) goes on to proscribe enforcement of the code: "Any hand-bill or sign found posted or otherwise affixed upon any public or utility property contrary to the provisions of this section may be removed by any company, utility, organization, or individual owning or responsible for maintaining that property, the Police Department or the Department of Public Works. The person responsible for any such illegal posting shall be liable for the cost incurred in the removal thereof, and the Department of Public Works is authorized to effect collection of said cost incurred by the City of Los Angeles" AND

WHEREAS: L.A.M.C. 28.M.C. 28.04, Sec (c) (2) describes in detail the responsible party to be charges for the posting as "person whose name or telephone number appears on the hand-bill or sign is the person responsible for posting a hand-bill or sign advertising property for sale, lease or rent" AND

WHEREAS: L.A.M.C. 28.M.C. 28.04 (c) (3), authorizes the Los Angeles Department of Public Works to remove the signs, set a cost for removal of illegal signs to be assessed on the offending party that posts illegal signs AND

WHEREAS: L.A.M.C. 28.M.C. 28.04 (c) (4), provides for due process for the party charged with posting illegal signs to appeal the levying of fins under L.A.M.C. 28.04, AND

WHEREAS: The City has the authority to place public notice of L.A.M.C. 28.M.C. 28.04, under (d) of the ordinance which states: "Nothing in this section shall apply to the installation of a metal plaque or plate or individual letters or figures in a sidewalk commemorating an historical,

cultural, or artistic event, location or personality for which the Board of Public Works, with the approval of the City Council, has granted a written permit" AND

WHEREAS: The City of Los Angeles has been unable to stem the blizzard of illegal signs in spite of L.A.M.C. 28.M.C. 28.04. It is the belief of both the West Valley Chamber of Commerce – Government Affairs Committee and Woodland Hills Warner Center Neighborhood Council Beautification Committee that:

- 1. The posting of illegal sign can be significantly reduced by providing adequate public notice to the public.
- 2. Once notified most members of the public will refrain from illegally posting signs.
- 3. The best places to provide public notice is at the site where violations, historically have occurred and can be anticipated to be repeated.
- 4. There is a sensible and simple way to provide the heretofore, missing notification.

THEREFORE: The Woodland Hills Warner Center Neighborhood Council and the West Valley Warner Center Chamber of Commerce resolve to request that the City of Los Angeles fabricate a medallion with the words "Post No Bills" along with the Los Angeles City logo and: L.A.M.C. 28.M.C. 28.04.
