Item no. (1) General Matters

Updates on local outreach opportunities in Woodland Hills, further discussion on homeless Forum in Woodland Hills and WH Homeless Connect Day.

Homelessness Forum as a joint collaboration with the County office, City Council offices, Neighborhood Council Office, Senator's office, and United Way. First meeting will be 9/23/18. Forum will be an educational style tabling event-a "homeless Connect Day" style event for housed individuals.

WH Homeless Connect Day is taking place 10/18 in Woodland Hills. Volunteers can speak with Councilman Blumenfield's office to get signed up. Flyers will be provided soon. Once provided, we will have them at our Homelessness Committee Meeting for distribution to homeless individuals in the area.

Ray conducted outreach per stakeholder's request at the Montecito apartments. 5 homeless individuals were in the property next door that is for sale. Stakeholders stated that they see these individuals from their balconies there. Handed out cards and gave information for Ascencia shelter intakes as well as advised they can contact if they need any assistance. Reported the encampment to LA-Hop.org. made contact with individuals in two RV's and two sleeping in their vehicles.

Item no. (2) Guest Speaker, United Way

Presentation from Simone Best of United Way on the Everyone In Campaign and how they are working to reduce homelessness in LA.

Simone Best from United Way gave a presentation on Permanent Supportive Housing. The presentation went over the number of people currently homeless in LA, how people become homeless, and how the Everyone In project is helping with the effort. Also, current supportive housing buildings and services were discussed. There was also a video showing a supportive housing unit with the perspectives of residents and the police department.

Discussed doing research on police relations with homeless, as well as CalTrans practices for clearing overpasses, underpasses, and near highway entrances. Research will result in possible CIS or Letters to city officials regarding reforming their practices. Discussed the passing of Joe, a homeless individual near Koreatown that did not have his heart medicine due to the police and a woman that was killed when CalTrans was clearing an area near the highway.
