Each year adult school students who do not have their high school diploma struggle to pay the \$150 test fee to take the HiSET (formerly the GED). Although classes are currently tuition free, each student must pay for their own HiSET exam.

5) How will this grant be used to primarily support or serve a public purpose and benefit the public at-large. (Grants cannot be used as rewards or prizes for individuals)

This grant will be used to support the administration of the HiSET exam to students in need. The HiSET is the high school equivalency test administered by the Los Angeles Unified School District. After passing the exam students are ready to pursue a career or transfer to a college or university. This benefits the community by allowing residents who previously were unqualified to gain employment or continue their education at an institution of higher learning.
