In conformity with the September 16, 2021 Enactment of California Assembly Bill 361 (Rivas) and due to concerns over COVID-19, the Woodland Hills-Warner Center Neighborhood Council meeting will be conducted entirely telephonically with a call-in option or internet based service option.

When calling-in telephonically, the public is requested to dial *9, when prompted by the presiding officer, to address the Board on any agenda item before the Board takes an action on an item. Zoom users should use the “raise hand” feature.

AB 361 Updates: Public comment cannot be required to be submitted in advance of the meeting, only real-time public comment is required. If there are any broadcasting interruptions that prevent the public from observing or hearing the meeting, the meeting must be recessed or adjourned. If members of the public are unable to provide

public comment or be heard due to issues within the Neighborhood Council’s control, the meeting must be recessed or adjourned.

Any messaging or virtual background is in the control of the individual board member in their personal capacity and does not reflect any formal position of the Neighborhood Council or the City of Los Angeles.

***PUBLIC INPUT ON AGENDA ITEMS** – The public may address the Board on any agenda item before the Board takes an action on an item. Comments from the public on agenda items will be heard only when the respective item is being considered. *Public comment is limited to 1.5 minutes per speaker.*

***PUBLIC INPUT ON MATTERS NOT ON THE AGENDA** - Comments from the public on other matters not appearing on the agenda *that are within the Board’s jurisdiction* will be heard during the General Public Comment period. 5. ZA-2021-8126-ZAD-ZAA 21055 W. Topochico drive, WH 91364

The project is located within Mulholland Scenic (Outer Corridor) area and Girard Track Specific Plan Area. The existing 12' wide unpaved street will be widened to 20 ft. Site has about 30-40% downslope from the street. Exist. protected trees will be replaced 1:4 ratio per Urban Forestry.

6. ZA-2003-4726-CUB-PA1 6500-6520 N. Canoga Avenue

Extend hours of operation to allow online sales and delivery of alcohol until 2:00 AM daily. The retail storefront would continue to close to the public pursuant to present in-store operating hours. See additional description attached

7. ZA-2021-9299-CUB 22001 Ventura Blvd, WH 91364

Conditional Use Permit to permit the sales of a full line of alcoholic beverages (ABC Type 21) for off-site consumption in conjunction with a 4,893 SF market with operating hours and alcohol sales hours both from 6:00 AM to 12:00 AM daily. The site is located in the C4-1VLD zone.
