On May 1, 2018 the City Clerk's Office notified WHWCNC that the newsletter will need to be reviewed and approved by the City Attorney's Office prior to the payment being issued.

The Department (collectively between EmpowerLA, Clerk's and City Attorney's Office) has been assisting and has forwarded the attached draft newsletter (received 5/16) for review by the City Attorney's Office. As of today, the advice is:
