Items for discussion and possible vote:

1.0 Homeless Encampment in Brush Areas

Should the NC Board advise the City Council to prioritize a focus on removing homeless encampments in brush areas to limit the risk of wildfires that can cause extensive damage.

Committee discussed recent brush fire events including the Sepulveda Basin Fire and the Bel-aire fire last summer caused by homeless encampments. Sean McCarthy related his eye-witness observations of what happened. Propane tanks were part of the danger. Council Member Blumenfield's River initiative to make Santa Monica Mountains Conservancy responsible for patrolling the LA River between Canoga Park and Reseda. Suggestions were offered regarding posting no trespassing signs and signs limiting flame-related cooking to specified areas cleared of brush. It was noted that there appears to be weak enforcement of existing signage and there is a need for a hotline to report encampments in fire-risk areas. Lauren Coffman to draft possible action for future meeting.

2.0 Warner Center Incentives

Should the NC Board request Councilman Blumenfield to expedite changes that would provide incentives for building more economical taller buildings that might more easily provide affordable housing units.

August Steurer suggested that the committee might propose that the City expedite use of Mass-Timber into the Building Code for use in Warner Center as a pilot. Discussion brought up the difficulties for implementation because the State has to approve it first.

3.0 Changes to City-wide Sign Ordinance ([CF 11-1705](#))

Should the NC Board support the proposed changes regarding off-site advertising signage under the sign ordinance? Should the NC Board recommend additional changes regarding on-site signs?

Minimal discussion due to a pending new report from City Planning to City Council Committee. Marty Lipkin offered to write a possible action for consideration at future meeting.
