Boeing Company spokespersons, Kamara Sams and Michael Bower provided a presentation and discussion related to the Santa Susana Field Lab (SSFL) site, final cleanup and end-use of the site. Conservation easement will prohibit all development in the future at SSFL site. Cleanup is consistent with mitigating all health risk and committed to clean up at that standard. Boeing committed to end use to be recreation and open space. Any comments about the ER need to address the items in the EIR and be submitted by Dec. 7, 2017. There are no alternatives or ranges of cleanup in the EIR as this was not a SEQA requirement.

As pertaining to Case DIR 2017-2544, having held one public meeting for the application filed by Kenneth Mayer, AIA to build a 3-story 2,887 square foot residence, an enclosed 892 sq. ft. three car garage and one onsite, uncovered parking spaces located at 4100 Carrizal Road, in the Girard Tract, Woodland Hills, CA 91364, the Board of the Woodland Hills-Warner Center Neighborhood Council hereby finds that:

WHEREAS, the Applicant has designed and submitted a proposed single-family residence project that substantially complies with the applicable regulations, findings, standards, and provisions of the Girard Tract Specific Plan, the Mulholland Scenic Parkway Specific Plan and the Baseline Hillside Ordinance; and

WHEREAS, the project is requesting a Residential Floor Area increase of 20% by compliance with the Cumulative Sideyard Setback Floor Area Bonus, and

WHEREAS, the applicant has agreed to and will note on their plans that the garage door and guardrails will be transparent glass; and

WHEREAS, the applicant has agreed to and will note on their plans that there will be no equipment located on the flat roof; and

WHEREAS, the applicant has agreed to and will note on their plans that exterior building lighting will be limited to path and entry lighting; and

WHEREAS, the applicant has agreed to and will note on their plans that there will be a substitution for the oleander specified on the landscape plan; and

WHERE AS, the applicant has agreed to and will note on their plans that the siding indicated is of non-flammable material instead of wood; and

WHERE AS, the applicant has agreed to and will note on their plans that the finish roofing material is a beige cool roof product;

THEREFORE, IT IS HEREBY RESOLVED that the Planning, Land Use and Mobility Committee, for the findings and conditions stated herein, finds that the submitted application and plans by Kenneth Mayer, AIA, for the proposed project at 4100 Carrizal Road, Woodland Hills, CA 91364, receive the support of the Board of the Woodland Hills-Warner Center Neighborhood Council for the requested actions contingent upon the following conditions:

## Item No. (8) PLUM Committee - Lauren Coffman and Don Patterson, Co-Chairs (16-217) 21400 block of West Marchena Street.

Motion related to dangerous conditions on the 21400 block of West Marchena Street.

Whereas, in the process of its Planning, Land Use and Mobility Committee reviewing case 2016-3103-ZAD currently pending in the Department of City Planning, the Board of the Woodland Hills – Warner Center Neighborhood Council has become aware that two or more public safety hazards exist in the public right-of-way for Marchena St., a substandard street, between Canoga Ave and Campo Rd.; and,

Whereas, city staff of five and possibly more city departments, which may include the Bureau of Streets, the Board of Public Works, plus the Departments of Building & Safety, Transportation, City Planning, and Water and Power, should have anticipated or seen these public hazards in the normal process of fulfilling their duties and apparently failed to notify appropriate officials of the hazards; and

Whereas, there was testimony from two neighbors adjacent to the roadway that incidents of property damage and near misses involving individuals and vehicles have occurred in the past resulting from the hazardous conditions that have existed and still exist in the public right of way for some time; and,

Whereas, one of the hazards consists of a public utility pole located in the middle of the designated public right-of-way intended for vehicular traffic, which obstructs normal passage and affects the safe use of the roadway by vehicles and adjacent properties; and,

Whereas, a second utility pole exists in the public right-of-way that is not accessible to vehicular and pedestrian traffic but appears so on city maps; and,

Whereas, another hazard is where the City officially designated the public right-of way for a downhill Walkway as a street under ordinance XXXXXX, which is impassable as stated above for both vehicles and pedestrians as it runs down a steep grade with one or more severe drops created by retaining walls across the public right-of-way; and,

Whereas, one or more vehicles a have in the past and it is still possible for vehicles to drive over the retaining wall edge and possible for individuals or animals to jump off the edge of the drop due to non-existence of any barrier at the end of the substandard roadway; and,

Whereas, the street signs at the Canoga Ave. and Campo Rd. may imply that the roadway functions as a roadway and not a walkway: and,

Whereas, both ends of this portion of Marchena St. are not posted as "Not a thru street;" and:

Whereas both ends of the street where it ceases to provide a travel way are not posted as "dead End;" and

Whereas there is no street lighting on Campo Rd or Marchena St. to illuminate the hazards ahead; and

Whereas, the Board considers these hazards dangerous enough to require immediate attention for rectification by City Departments and agencies and failure to do so might be considered negligence by the City;

Therefore, to protect the interests of the citizens of Los Angeles, the Board of the Woodland Hills – Warner Center Neighborhood Council hereby resolves to notify Los Angeles City Council District 3 and the Los Angeles City Attorney of the existence of two or more public safety hazards as mentioned in the preceding findings and requests that they take all necessary and appropriate actions to notify all affected city departments and agencies of the hazards for their immediate inspection and investigation and to initiate and approve use of necessary contingency/emergency funds from the responsible departments and agencies to as-quickly-as-possible remove and/or mitigate all hazards that exist in the Marchena St. public right-of-way east of Campo Rd at no cost to adjacent property owners when they have not created the hazards.

This resolution shall be sent to District 3 Councilmember Bob Blumenfield, City Attorney Mike Feuer and the City Clerk.

#### Motion to Approve Increased Newsletter Print Run & Cost -Color Fx

Whereas, the WHWCNC is now in the process of printing and mailing a new 16-page full color newsletter and the mailing number has increased from 37,824 to 40,171 since the process started. At the start of the project the print run was set to 41,000 and paid for, to provide 3,176 extra newsletters for personal delivery within the community.
