3.0 Resolution asking City of Los Angeles to support Online Job Listing Salary Range Disclosure

Possible action regarding amending the California Labor Code, Section 432.3, to require Employers who post jobs online to disclose the Salary Range for the position, instituting penalties for non-compliance, and closing loopholes that allow Employers to circumvent these laws using third-party job boards which are in violation of Assembly Bill 168 passed in 2017.
